#### **RESOLUTION #139-13**

**RESOLVED**, to adopt LOCAL LAW NO. 1 OF 2014, "A LOCAL LAW AMENDING VILLAGE CODE § 153-3 STOP AND YIELD SIGNS."

BE IT ENACTED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF HEAD-OF-THE-HARBOR AS FOLLOWS:

SECTION 1. PURPOSE.

The purpose of this local law is to regulate the obstruction of traffic at intersections in supplement of N.Y. Vehicle and Traffic Law § 1175.

SECTION 2. AMENDMENT OF VILLAGE CODE § 153-3 STOP AND YIELD SIGNS\*

A. The title of § 153-3 is amended to read Stop and Yield Signs and Marked Intersection Signs.

B. Section 153-3(C) is enacted as follows:

C. Notwithstanding any official traffic control signal indication to proceed and excepting the order of a police officer otherwise, a driver of a vehicle shall not enter an intersection unless there is sufficient space on the other side of the intersection to accommodate completely the vehicle driven without obstructing in any manner the through passage of vehicles from either side. In no event shall a driver enter an intersection described in Schedule D below marked by a Do Not Block Intersection sign except while observing the restrictions of this subsection.

C. Section 153-3, Schedule D, is enacted as follows:

SCHEDULE D. MARKED INTERSECTIONS

Name of Street Direction of Travel Cross Street

Edgewood Avenue East Fifty Acre Road

SECTION 3. SEQRA.

This is a Type II action under 6 NYCRR 617.5(c)(20).

SECTION 4. SEVERABILITY.

Should any part or provision of this local law be decided by the courts to be unconstitutional or invalid, such decision shall not affect the validity of the local law as a whole nor any part thereof other than the part so decided to be unconstitutional or invalid.

SECTION 5. EFFECTIVE DATE.

This local law shall take effect immediately upon filing with the Secretary of State as provided by law.

**RESOLUTION #140-13** 

**RESOLVED,** LOCAL LAW NO. 2 OF 2014, "A LOCAL LAW AMENDING VILLAGE CODE §165-23(B)(3)(D)" BE IT ENACTED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF HEAD-OF-THE-HARBOR AS FOLLOWS: SECTION 1. PURPOSE.

The purpose of this local law is to amend Village Code § 165-23(B)(3)(d) consistent with the requirements of New York Agriculture and Markets Law § 305-a(1).

SECTION 2. AMENDMENT OF VILLAGE CODE § 165-23(B)(3)(d).

Village Code § 165-23(B)(3)(d) is amended to read as follows\*:

(d) Except as otherwise allowed under New York Agriculture and Markets Law § 305-a(1) on premises within a county adopted state certified agriculture district, agricultural pursuits shall not include any use which causes or allows public assembly for purposes of attending a social event or an entertainment event, and instead, agricultural pursuits shall be limited to the growing of crops, raising of livestock and sale of livestock products as defined in Section 301 of the New York Agriculture and Markets Law.

SECTION 3. SEQRA.

This is a Type II action under 6 NYCRR 617.5(c)(20).

SECTION 4. SEVERABILITY.

Should any part or provision of this local law be decided by the courts to be unconstitutional or invalid, such decision shall not affect the validity of the local law as a whole nor any part thereof other than the part so decided to be unconstitutional or invalid.

SECTION 5. EFFECTIVE DATE.

This local law shall take effect immediately upon filing with the Secretary of State as provided by law.

Upon the receipt of the roll you, on or before the first day of March, you shall cause to be published in the official paper of the Village, once a week for two consecutive weeks, a notice that such tax roll has been left with you for the collection of taxes therein levied, and shall designate one or more convenient places in the Village where you will receive taxes from March first to and including April first from nine o'clock in the morning until 2 o'clock in the afternoon, except Fridays, Saturdays, Sundays and holidays; For said period of time you will receive all taxes paid to you without additional charge; On all such taxes remaining unpaid after

April first, interest of five percent shall be added for the month of April and an additional one percent for each month and fraction thereof thereafter until paid. After the first day of April you shall proceed to collect the taxes remaining unpaid, with interest as herein provided, but without any other fee or charge, and for that purpose you are possessed of all the powers of tax collector. All interest collected shall belong to the Village.

**RESOLVED**, extending the residency requirement to include the County of Suffolk, the following individuals are appointed to serve as election inspectors for the March 18, 2014 General Election, namely Maureen Wiedersum Chief Inspector, Marguerite McDonagh, and Leane Kondenar. Chief Election Officer, Margaret O'Keefe for a work day from 11:30 AM until 9:30 PM, compensation to be \$140.00 for the 10 hour day. Oaths of Office are to be filed with the village clerk; I-9 forms are to be filed with the village treasurer.
