WHEREAS, there is a vacancy on the Joint Coastal Commission, and WHEREAS, village resident John Delaney has expressed interest in this position, and WHEREAS, the Joint Coastal Commission has put forth his resume to the Board of Trustees, BE IT RESOLVED, to appointment John Delaney to the Joint Coastal Commission to fulfill the current vacancy; this term expires April 2018.

BE IT RESOLVED, to sign user roles of Grantee Margaret O'Keefe; Grantee Delegated Administrator Margaret O'Keefe; Grantee Contract Signatory Judith C. Ogden; and Grantee System Administrator Douglas A. Dahlgard, and

BE IT FURTHER RESOLVED that the Village of Head of the Harbor hereby authorizes the submittal of this application; and that upon approval of said grant, Mayor or his designee is hereby authorized to enter into and execute a project agreement with the New York State Department of Environmental Conservation for such financial assistance.
