RESOLVED, to adopt the minutes of April 21, 2021 meeting as presented.

WHEREAS, Village Justice Ellen D. Fishkin resigned effective May 6, 2021, and

WHEREAS, in accordance with Village Law §3-300(2) the Board of Trustees does hereby extend the Village Justice's residency requirements to within the County of Suffolk, and subject to other requirements for holding public office, and

WHEREAS, the Village Justice shall be compensated at the salary of Five Hundred Dollars (\$500.00) each session of the court that he presides, not to exceed two (2) sessions any calendar month, subject to submission of voucher as required under Village Law §5-524,

NOW THEREFORE, in accordance with Village Law §3-312 Mayor Dahlgard hereby appoints Hon. John J. Toomey, Jr. Residing at 12 King Arthur Court, St. James, County of Suffolk, New York as Village Justice effective until the General Election of March 2022, and it is further

RESOLVED, the Hon. John J. Toomey, Jr., Village Justice, is authorized in his official capacity to open a Justice Court Account, with TD Bank, and to authorize Mayor Dahlgard to be assigned as second signatory, **BE IT FURTHER RESOLVED**, the village treasurer is authorized and directed to deposit the amount of \$500.00 in village funds to cover administrative costs. This resolution is effective immediately.

Said employment is contingent upon Ms. Darrigo successfully passing a background investigation. This appointment is effective immediately.
