MINUTES OF THE MEETING OF THE BOARD OF TRUSTEES Wednesday, May 20, 2020

A meeting of the Board of Trustees of the Incorporated Village of Head-of-the-Harbor was held on Wednesday, May 20, 2020 at 7 PM via Zoom Video Conferencing. Those present were the following members Mayor Douglas A Dahlgard, Deputy Mayor Daniel W. White, Trustees L. Gordon Van Vechten, Judith C. Ogden and Trustee Jeffrey D. Fischer. Also in attendance Village Administrator/Clerk, Margaret O'Keefe; Village Treasurer, Patricia Mulderig; Village Attorney, Anthony S. Guardino; Co-Counsel, Philip Butler and Building Inspector, Robert O'Shea. Not in attendance Police Chief, Charles M. Lohman. Also joining were village residents Leighton Coleman, Margaret Shutka, Michael Utevsky and Alexandra Leighton.

1. Mayor – Douglas A. Dahlgard

Mayor Dahlgard convened the public hearing on Local Law (Intro.) #2 of 2020, "A Local Law Amending Chapter 88 of The Code of The Village Of Head of the Harbor With Respect To Fees And Deposits In Connection With The Review of Land Use Applications". Discussion ensued. Resident Michael Utevsky expressed concerns. Further clarification of intent of the local law was provided.

The public hearing on Local Law (Intro.) #3 of 2020, "A Local Law Amending Chapter 59, 81, 143 and 165 of The Code of The Village Of Head of the Harbor With Respect To Fees And Deposits In Connection With The Review of Land Use Applications" was convened. Discussion ensued. Further discussion and opposition expressed by resident Michael Utevsky.

It was upon motion by Mayor Dahlgard, second by Trustee Fischer, unanimously to close the public hearings on Local Law (Intro.) #2 of 2020, "A Local Law Amending Chapter 88 of The Code of The Village Of Head of the Harbor With Respect To Fees And Deposits In Connection With The Review of Land Use Applications" and Local Law (Intro.) #3 of 2020, "A Local Law Amending Chapter 59, 81, 143 and 165 of The Code of The Village Of Head of the Harbor With Respect To Fees And Deposits In Connection With The Review of Land Use Applications".

• On Wednesday, April 15, 2020 the Board of Trustees of the Incorporated Village of Head-of-the-Harbor adopted RESOLUTION # 007-20 scheduling a public hearing pursuant to Chapter 66 of the Village Code to be held tonight May 20, 2020. The purpose of tonight's public hearing is to determine whether the building or structures located at the 3 Pin Oak Lane Head-of-the-Harbor, Suffolk County, bearing Suffolk County Tax Map Number 801-4-2-23, are unsafe or dangerous to the public or unsanitary pursuant to the provisions of Chapter 66 and must be removed, and further assess whether the condition of the structures on the premises pose a risk or threat to the health and safety of the general public and must be removed.

The scheduling of the public hearing was as result of the building inspectors report dated October 21, 2019. That report was accepted by the Village Board of Trustees. It is my understanding, as well as the members of this Board, that the conditions that were the subject of the April 15, 2020 resolution, requiring tonight's public hearing, still remain. As such, we are obligated to proceed with tonight's public hearing to determine whether the building at 3 Pin Oak Ln. is unsafe and/or dangerous to the public and must be removed.

Letters were sent via regular and Certified R/R/R to the property owner Scott Felicetti and the mortgagee Barbara Schumer. (Proof of mailings should be placed on the record and filed with the Village Clerk as part of the record.) The notice was also posted at the property. In speaking with our building inspector, Robert O'Shea, he has not received any response from the property owner or the mortgagee. The conditions remain unchanged.

As set forth in the report of Mr. O'Shea, the particulars why the building is unsafe are as follows:

- 1. Collapsed section of main house
- 2. Complete overgrowth of all buildings and structures
- 3. Broken and missing windows
- 4. Rotted window frames
- 5. Collapsed exterior stairs on accessory buildings
- 6. Birds and rodents entering and exiting buildings
- 7. Holes in roof and walls of all buildings
- 8. Rubbish strewn about the property
- 9. Collapsed swimming pool with ponding of stagnant water
- 10. Peeling, flaking and chipped paint on all buildings
- 11. Broken or missing handrails and guards
- 12. Overall and complete neglect of the property and all buildings and structures on it

Each of these items represents a violation of one or more sections of the 2015 International Property Maintenance Code as amended by the 2017 New York State Uniform Code Supplement. The structures have been damaged through deterioration, neglect and abandonment to such an extent that they are likely to completely or partially collapse. The buildings and structures are clearly unsafe for use and occupancy. The buildings are neglected, damaged, dilapidated, unsecured and abandoned so as to become an attractive nuisance to children who might play in them to their danger, and become a harbor for vagrants, criminals, immoral persons, or enable persons to resort to them for committing a nuisance or an unlawful act.

The purpose of tonight's hearing is to consider whether to order the removal of said structures and to assess costs against the premises. Discussion ensued. Neither Mr. Scott Felicetti nor the mortgagee Ms. Barbara Schumer attended. Mr. O'Shea stated that the condition of the property has not improved since his earlier report, and has in fact deteriorated further. Further discussion on the condition of the property ensued. It was upon motion by Mayor Dahlgard, second by Deputy Mayor White, and unanimously adopted to close the hearing.

2. Mayor – Douglas A. Dahlgard

- It was upon motion by Deputy Mayor White, second by Trustee Van Vechten, and unanimously adopted: **RESOLUTION #018-20 RESOLVED**, Local Law (Intro.) #2 of 2020. "A Local Law Amending Chapter 88 of the Code of Village of Head of the Harbor with respect to fees and deposits in connection with review of Land Use Applications" is found to be a Negative Declaration under SEQRA."
- It was upon motion by Deputy Mayor White, second by Trustee Van Vechten, and unanimously adopted: **RESOLUTION #019-20 RESOLVED**, to adopt Local Law (Intro.) #2 of 2020, "A Local Law Amending Chapter 88 of The Code of The Village Of Head of the Harbor With Respect To Fees And Deposits In Connection With The Review of Land Use Applications".
- It was upon motion by Trustee Fischer, second by Trustee Ogden, and unanimously adopted: **RESOLUTION #020-20 RESOLVED**, with regard to Local Law (Intro.) #3 of 2020, "A Local Law Amending Chapter 59, 81, 143 and 165 of the Code the Village of Head of the Harbor With Respect To Fees and Deposits In Connection With The Review of Land Use Applications," **BE IT RESOLVED**, that the Board of Trustees finds this amendment to be a Negative Declaration under

SEQRA."
It was upon motion by Trustee Van Vechten, second by Trustee Ogden, and unanimously adopted: RESOLUTION #021-20

RESOLVED, to adopt Local Law (Intro.) #3 of 2020, "A Local Law Amending Chapter 59, 81, 143 and 165 of The Code of The Village Of Head of the Harbor With Respect To Fees And Deposits In Connection With The Review of Land Use Applications".

• It was upon motion by Trustee Fischer, second by Trustee Van Vechten, and unanimously adopted: **RESOLUTION #022-20**

RESOLVED, that pursuant to the public hearing vote on May 20, 2020 premises known as 3 Pin Oak Lane, SCTM # 4.-2.-23. The Building Inspector is authorized to prepare and to mail a second notice to the last known owner of the property and the Mortgagee asking for a receipt of their reasonable time of 10 days for a receipt and also that the will Village Clerk schedule a public hearing with regard to action on 3 Pin Oak Lane for the July 15, 2020 Board of Trustees meeting at 7 PM if allowed by the Executive Orders it will take place at 500 North Country Road, St. James New York 11780 if not the Zoom platform will be utilized.

BE IT RESOLVED, the Board of Trustees authorizes the following individuals be listed as the HMP Points of Contact; primary point of contact Mayor Douglas A. Dahlgard, alternate point of contact Deputy Mayor White and Mr. O'Shea as Flood Plan Administrator.

3. BUILDING DEPARTMENT- Robert O'Shea, Building Inspector:
