MINUTES OF THE MEETING OF THE BOARD OF TRUSTEES Monday, September 18th, 2017 7 PM

A meeting of the Board of Trustees of the Incorporated Village of Head-of-the-Harbor was held on Monday, September 18, 2017 at 7 PM at the Village Hall located at 500 North Country Rd., St. James, NY 11780. Those present were the following members Mayor Douglas A. Dahlgard, Deputy Mayor Daniel W. White, Trustees Judith C. Ogden, L. Gordon Van Vechten and Jeffrey D. Fischer. Also in attendance Building Inspector Robert O'Shea, Village Clerk Margaret O'Keefe, Police Chief Charles M. Lohmann, and Village Attorney Anthony B. Tohill. Not in attendance this evening, Village Treasurer Patricia Mulderig.

1. Mayor – Douglas A. Dahlgard:

• Mayor Douglas Dahlgard convened the public hearing on Local Law (Intro.) #1 of 2017, "A LOCAL LAW AMENDING VILLAGE CODE §123-4". Discussion ensued. There being no further comments it was, upon motion by Trustee White, second by Trustee Fischer and unanimously adopted:

RESOLUTION #107-17

RESOLVED, to close the public hearing on Local Law (Intro.) #1 of 2017, "A LOCAL LAW AMENDING VILLAGE CODE §123-4".

- A public hearing was concluded on the 18th day of September 2017, at 7:00 P.M., at the Village Hall, 500 North Country Road, Head-of-the-Harbor, New York, to consider the adoption of Local law # 1 of 2017, "A LOCAL LAW AMENDING VILLAGE CODE §123-4"

RESOLVED, LOCAL LAW (Intro) NO. 1 OF 2017, "A LOCAL LAW AMENDING VILLAGE CODE §123-4" BE IT ENACTED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF HEAD-OF-THE-HARBOR AS FOLLOWS.

PURPOSE.

The purpose of this local law is to enable a deer fertility program authorized by the New York State Department of Environmental Conservation to be conducted within the Village of Head-of-the-Harbor. AMENDMENT OF VILLAGE CODE § 123-4.

Section 123-4 is amended by addition of the following:

In no event shall this subsection restrict the discharge of immunocontraception vaccine and/or chemical immobilization darts by a person issued a license and/or permit under New York Environmental Conservation Law § 11-0515 and/or 6 New York Codes, Rules and Regulations Part 175. SUPERSESSION.

This Local Law shall supersede any inconsistent law, state or local. This declaration of supersession is made by authority of the Village's municipal home rule law powers, pursuant to §\$10(1)(ii)(a)(14) and 10(1)(ii)(e)(3) of the Municipal Home Rule Law, §10(6) of the Statute of Local Governments, and Article 9, §2(b)(3) of the New York State Constitution.

SEVERABILITY.

Should any part or provision of this local law be decided by the courts to be unconstitutional or invalid, such decision shall not affect the validity of the local law as a whole nor any part thereof other than the part so decided to be unconstitutional or invalid.

EFFECTIVE DATE.

This local law shall take effect immediately upon filing with the Secretary of State as provided by law.

NOW, THEREFORE, IT IS HERBY RESOLVED, that the Board of Trustees of the village of the Head of the Harbor does hereby acknowledge that the audit of the records of the Village Justice Court required under the Uniform Justice Court Act \$ 2019-a has been conducted, and that the Justice Court Audit Report has been received by the Board, and it is hereby further,

RESOLVED, that the Village Clerk forward to the New York State Office of Court Administration a copy of said Justice Court Audit Report and a copy of this Resolution.
