A meeting of the Board of Trustees of the Incorporated Village of Head-of-the-Harbor was held on Wednesday, November 19, 2014 at 7 PM at the Village Hall located at 500 North Country Rd., St. James, NY 11780. Those present were the following members Mayor Douglas A. Dahlgard, Deputy Mayor Daniel W. White, Trustees Judith C. Ogden, L. Gordon Van Vechten and Jeffrey D. Fischer. 1. Mayor – Douglas A. Dahlgard:

Mayor Dahlgard convened the public hearing on this 19th day of November 2014, at 7:00 P.M., at Village Hall, 500 North Country Road, St. James, New York, to consider the adoption of LOCAL LAW NO. 5 OF 2014, "A LOCAL LAW TO OVERRIDE THE TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW § 3-c". Much discussion ensued. It was, upon motion by Trustee White, second by Trustee Fischer and unanimously adopted:

WHEREAS, the police department has taken ownership of a 2014 Ford Explorer, **BE IT RESOLVED**, the 2008 Dodge Durango has been deemed surplus equipment.

• It was, upon motion by Trustee White, second by Trustee Fischer and unanimously adopted:

RESOLUTION #135-14

WHEREAS, the Board of Trustees finds that the 2008 Dodge Durango police vehicle is surplus and will be placed for sale,

WHEREAS, the Chief of Police has confirmed that this vehicle is surplus, and

WHEREAS, the Board and the Police Department have investigated the fair market value for the 2008 Dodge Durango, and

WHEREAS, the Board has established through Kelley Blue Book and other reliable standard resources, that the total value of these vehicles is less than \$20,000, and

WHEREAS, John Gerlach is an employee and member of the village police department, and

WHEREAS, as Mr. Gerlach wishes to purchase one of the vehicles, and

WHEREAS, Mr. Gerlach has disclosed his status as a village employee, and

WHEREAS, Mr. Gerlach has agreed to pay to the village a sum in excess or equal of the Kelley Blue Book value, to wit the sum of \$5,500.00.

NOW THEREFORE, based on all of these elements the Board of Trustees approves of the sale of the vehicle selected by officer Gerlach for the sum of \$5,500.00.

RESOLVED, the building inspector is authorized and directed to notify J. Timothy Shea, Esq. that his request dated October 17, 2014 for the extension of the building permit issued to Dieter Kopf on July 30, 2014 is approved pursuant to §65(5)(I) of the Village Code,

With the proviso that any further request for an extension should be submitted to the village not later than 90 days prior to July 30, 2015, and

With the further proviso that the village would not considered favorably any further extension of time absence the demonstration of good cause and the personal appearance of either Dieter Kopf or Mr. Shea on his behalf.

BE IT FURTHER RESOLVED, Mayor Dahlgard is hereby authorized to sign the agreement, in his official capacity, on behalf of the Village of Head of the Harbor for the lease of said copier for a term of 5 years.

NO. 5 OF 2014, "A LOCAL LAW TO OVERRIDE THE TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW § 3-c"

Resolution #145-14

RESOLVED, to adopt Local Law #5 of 2014, "A LOCAL LAW TO OVERRIDE THE TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW § 3-c"

BE IT ENACTED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF HEAD-OF-THE-HARBOR AS FOLLOWS:

SECTION 1. PURPOSE.

It is the intent of this local law to allow the Village of Head-of-the-Harbor to adopt a budget for the fiscal year commencing March 1, 2015 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

SECTION 2. AUTHORITY.

This local law is adopted pursuant to subdivision 5 of General Municipal Law § 3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body. SECTION 3. TAX LEVY LIMIT OVERRIDE.

The Board of Trustees of the Village of Head-of-the-Harbor, County of Suffolk, is hereby authorized to adopt a budget for the fiscal year commencing March 1, 2015 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law § 3-c.

SECTION 4. SEVERABILITY.

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

SECTION 5. EFFECTIVE DATE.

This local law shall take effect immediately upon filing with the Secretary of State.

All persons in interest will be heard by the Board of Trustees at the public hearing to be held as aforesaid and may

appear in person or by representative. The Village Hall is accessible to handicapped persons.

8. Highway Department- Judith C. Ogden, Commissioner:

- Extensive vehicle repair; equipment is ready for winter.
- Testing of radio equipment to occur Saturday, November 22, 2014.
