BE IT FURTHER RESOLVED, a planting ceremony is to commence at 9:30am on Watercrest Lane, all are welcome to attend.

Overtime at the rate of time and one-half of the employee's regular hourly rate shall be paid to employees who work more than forty (40) hours in any work week, and who are not exempt from overtime requirements. If an employee is unsure as to his/her exempt status, please speak to the VILLAGE Clerk. No overtime for which time and one half or double time, as set forth below, is required to be paid shall be worked unless prior approval is provided by the employee's supervisor, the Mayor, or the Board of Trustees. In additional, employees who are directed to work overtime are expected and may be required to do so. For purposes of calculating overtime only, paid time off shall be included in determining if the employee has worked forty (40) hours. Regardless of whether an employee has worked the forty (40) hour per week threshold, any non-exempt full-time employee who is called in due to snow or other emergency situation shall receive compensation as follows:

- a) if called in prior to 4:00am Monday through Friday, compensation shall be at double time, with a four (4) hour minimum;
- b) if called in after 4:00am but prior to the beginning of the regular shift, compensation shall be at time and one-half for the number of hours worked;
- c) if called back after leaving work at the end of the regular shift, compensation shall be at double time with a four (4) hour minimum;
- d) if called out on the employee's regularly scheduled day off, compensation shall be at double time with a four (4) hour minimum. This resolution will be added effective retroactively to October 16, 2019.

RESOLVED, the village clerk is authorized and directed to have copies of this amendment on the signature page signed by each employee of the village and maintain those signed copies as part of the village records.
