RESOLUTION DECLARING THE HEAD OF THE HARBOR BOARD OF TRUSTEES AS THE LEAD AGENCY FOR PURPOSES OF A COORDINATED ENVIRONMENTAL REVIEW PURSUANT TO SEQRA FOR A PROPOSED HOUSE OF WORSHIP ON REAL PROPERTY LOCATED AT 481 NORTH COUNTRY ROAD IN HEAD OF THE HARBOR

WHEREAS, the Monastery of the Glorious Ascension, Inc. ("Applicant"), as owner of the premises known as 481 North Country Road, Saint James, New York (SCTM: 0801-007.000-03.00-029.001, 037.000), has applied to the Village of Head of the Harbor Board of Trustees ("Board of Trustees"), pursuant to Section 165-23(B)(1) of the Village Code, seeking a special permit for the construction of a place of religious worship on said premises (the "Project"); and

WHEREAS, the Project will further require site plan approval from the Head of the Harbor Planning Board, one or more variances from the Head of the Harbor Zoning Board of Appeals, architectural approval from the Head of the Harbor Board of Architectural Review, and approvals from several non-Village agencies; and

WHEREAS, pursuant to Section 81-24(D), (F), (H), and (I) of the Village Code, the Project is reclassified as a Type I Action for purposes of SEQRA review; and

WHEREAS, on November 20, 2021, the Board of Trustees adopted a resolution declaring its intent to serve as Lead Agency for purposes of a coordinated environmental review of the Project pursuant to SEQRA; and

WHEREAS, on December 7, 2021, the Village Clerk circulated a written notice of intent to all Involved Agencies identified for the Project; and

WHEREAS, more than thirty (30) days have elapsed since the notice of intent was sent, and no objection has been filed by any Involved Agency;

NOW THEREFORE, BE IT RESOLVED, that the Board of Trustees of the Village of Head of the Harbor hereby:

- Declares itself Lead Agency for purposes of a coordinated environmental review pursuant to SEQRA for the Project; and
- Directs the Village Clerk to send a copy of this resolution to the applicant, and to all Involved Agencies.
