Discussion ensued. Upon the conclusion of comments from the Board and the public, Mayor Dahlgard closed public hearing.
- Mayor Dahlgard convened the public hearing on this 17th day of March 2021, at 7:00 PM for consideration of adoption of the "Village of Head of the Harbor Police Reform and Reinvention Collaborative Plan".
 Discussion ensued. Upon the conclusion of comments from the Board and the public, Mayor Dahlgard closed public hearing.
- A public hearing was concluded on the 17th day of March 2021, at 7:00 PM, via ZOOM platform, to consider
 the adoption of a local law as Local Law (Intro) #2 OF 2021, "A LOCAL LAW TO ALLOW SPECIAL
 DEFERMENTS AND INSTALLMENT PAYMENTS DURING THE COVID-19 STATE OF
 EMERGENCY". Deemed read into the record as follows:

LOCAL LAW NO. 2 OF 2021 REGARDING DEFERMENT OF VILLAGE PROPERTY TAXES DURING THE COVID-19 STATE OF EMERGENCY

Be it hereby enacted by the Board of Trustees of the Incorporated Village of Head of the Harbor as follows:

Section 1. Purpose and Intent.

On January 30, 2021, the Governor signed into law Senate Bill No. 8138-B of 2020, which enacted Section 1910 of the Real Property Tax Law (RPTL). Under the new law, local taxing jurisdictions are permitted to adopt a single local law deferring the deadline for payment of property taxes in response to a declared state of emergency. In light of the on-going hardships related to the COVID-19 state of emergency, the Board of Trustees finds that it shall be in the best interests of the Village of Head of the Harbor and its residents to take advantage of this opportunity by deferring the deadline for payment of village property taxes on a short-term basis.

Section 2. Enactment.

Pursuant to RPTL § 1910, the Board of Trustees hereby decrees that the current deadline for the payment of village property taxes is hereby extended from April 1, 2021, to May 1, 2021. Accordingly, notwithstanding any State or local law to the contrary, village property taxes due for the 2021 tax year will be treated as timely, and may be paid without penalty or interest, if paid or postmarked on or before May 1, 2021. Nothing herein shall affect the deadline for payment of taxes assessed by any other municipal subdivision, school district, or special district.

Section 3. Severability.

If any clause, sentence, paragraph, section, or part of this local law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder hereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part hereof directly involved in the controversy in which judgment should have been rendered.

Section 4. Effective date.

This local law shall take effect immediately upon filing with the New York Secretary of State.

WHEREAS: The Police Reform & Reinvention Collaborative was directed by Governor Cuomo's Executive Order of June 12, 2020; and

WHEREAS: All municipalities in New York State that have police forces are required to participate and submit a written plan by April 1, 2021; and

WHEREAS: If communities to fail to submit a written plan, their funding will be withheld by the NYS Department of Budget; and

WHEREAS: This process was structured, according to the guidelines provided in the New York State Police Reform and Reinvention Collaborative, requiring community input and participation, along with an assessment of policing policies; and

WHEREAS: Village of Head of the Harbor understands that maintaining public safety is extremely important and is one of the essential roles of government. In order to achieve that goal, there must be mutual trust and respect between police and the communities they serve; and

WHEREAS: Village of Head of the Harbor has followed the guidelines of the Police Reform & Reinvention Collaborative in the following ways:

- Reviewed the needs of the community served by the Village of Head of the Harbor Police Department and evaluated the Department's current policies and practices.
- Established and evaluated policies that allow Police Officers to safely perform their duties.
- Involved the entire community in the discussion by way of a public meeting held on January 27, 2021.
- Reviewed comments and recommendations that were received from the public.
- Produced a draft VILLAGE OF HEAD OF THE HARBOR POLICE REFORM & REINVENTION COLLABORATIVE PLAN, ("The Plan") and made copies available to the public beginning on March 4, 2021.
- A public hearing was held on March 17, 2021 to consider the adopting of "The Plan", and

WHEREAS: The Village of Head of the Harbor Board of Trustees has read, reviewed, and agreed with the information presented in "The Plan"; therefore, be it,

RESOLVED: That the Village of Head of the Harbor Board of Trustees accepts and adopts the Village of Head-ofthe-Harbor Police Reform & Reinvention Collaborative Plan; and be it further

BE IT FURTHER RESOLVED: That the Village of Head of the Harbor's Board of Trustees, upon adoption of this resolution, will authorize and direct the submission of "The Plan" and the New York State Police reform and Reinvention Collaborative Plan Certification Form to the Director of the New York State Division of the Budget on or before the established deadline of April 1, 2021 to be in full compliance.
