## 4. Highway Department- J. Ted Naughton, Commissioner:

- Highway employee injured his left hand on September 27, 2012.

**RESOLVED,** the building inspector is authorized to approve a permit under Chapter 131 of the Village Code with the proviso that any such approval would be based on facts of this particular case and this particular residence at 26 Pin Oak Lane and that this particular approval does not serve as any amendment or modification of the existing policy requiring curb to curb restoration of the pavement and no part of the issuance can be construed as to constitute an amendment of the existing policy and said policy shall continue.

- Discussion regarding drainage work and paving to be done on Gate Road. The project would utilize state bids and CHIPS funds. Discussion ensued. Test boreing to begin.

# 6. Police Department - Chief Thompson:

#### 7. Other Matters:
