# MINUTES OF THE MEETING OF THE BOARD OF TRUSTEES Wednesday, November 21, 2012 at 7 PM

A meeting of the Board of Trustees of the Incorporated Village of Head-of-the-Harbor was held on Wednesday, November 21, 2012 at 7 PM at the Village Hall located at 500 North Country Rd, St. James, NY 11780. Those present were the following members Mayor Natale J. Tartamella, Trustees R.L. Swanson, Heiko Folkerts, J. Ted Naughton, and Judith C. Ogden. Also in attendance this evening Village Clerk; Margaret O'Keefe and Patricia Mulderig, Treasurer. Not in attendance this evening Village Attorney; Anthony B. Tohill.

### • Mayor – Natale Tartamella:

• Mayor Tartamella convened the public hearing on this 21<sup>st</sup> day of November 2012, at 7:00 P.M., at Village Hall, 500 North Country Road, St. James, New York, to consider the adoption of LOCAL LAW NO. 1 OF 2012, "A LOCAL LAW TO OVERRIDE THE TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW § 3-c". Residents Mr. Coleman and Ms. Swanson expressed concerns that the hearing was being held on the eve of Thanksgiving, therefore potentially limiting the public's availability to attend. Discussion ensued. Members of the Board of Trustees explained that the hearing was on the above referenced local law and not the 2013/2014 budget. **RESOLVED**, the village General Election will be held on Tuesday, March 19, 2013 and the polls are to be open 12 noon-9 PM; the polling is to take place at Head of the Harbor Village Hall, 500 North Country Rd., St. James, NY 11780. The building is accessible to handicapped persons.

- Discussion regarding draft legislation regarding curb cuts and driveways; berm regulations; enhancing setbacks for certain accessory uses. Said drafts to be sent to the Planning Board for comment. No action taken.

Resolution #117-12

**RESOLVED**, to adopt Local Law #1 of 2012, "A LOCAL LAW TO OVERRIDE THE TAX LEVY LIMIT ESTABLISHED IN GENERAL MUNICIPAL LAW § 3-c"

BE IT ENACTED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF HEAD-OF-THE-HARBOR AS FOLLOWS:

## SECTION 1. PURPOSE.

It is the intent of this local law to allow the Village of Head-of-the-Harbor to adopt a budget for the fiscal year commencing March 1, 2013 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law § 3-c.

This local law is adopted pursuant to subdivision 5 of General Municipal Law § 3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body. SECTION 3. TAX LEVY LIMIT OVERRIDE.

The Board of Trustees of the Village of Head-of-the-Harbor, County of Suffolk, is hereby authorized to adopt a budget for the fiscal year commencing March 1, 2013 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law § 3-c.

SECTION 4. SEVERABILITY.

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall not affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

SECTION 5. EFFECTIVE DATE.

This local law shall take effect immediately upon filing with the Secretary of State.

• It was, upon motion by Trustee Naughton, second by Trustee Folkerts, and unanimously adopted Resolution #118-12

**RESOLVED**, to adopt the following Policy for Head of the Harbor Village Board Membership:

To request nomination of a Board member for approval by the Village Board of Trustees, let the Committee Chair submit in writing:

- 1. the reason why' they' have selected said nominee; include an explanation of the vacant seat and reason why candidate would be a good fit, and
- 2. a letter or resume from nominee explaining why they would like to serve on the board and the expertise or attributes they could provide.

Whereas there is considerable talent and expertise among the residents of Head-of-the-Harbor, and the residents have a vested interest in the management of the Village, it is the policy of the Village that members of Village boards be residents of the Village.

Exceptions to this policy might occur if and only if the respective Village Board has demonstrated that, following and extensive search; there is no resident available to fill the Board vacancy, that there be a written appeal to the Village Board of Trustees upon which the Board of Trustees will assist the respective Board in seeking qualified resident nominees.

Failing the above, the Village Board may submit the name of a non-resident nominee to the Board of Trustees for consideration. The non-resident nominee must be able to demonstrate that they have:

- 1. expertise (through education, experience) in a field of endeavor that meets the needs of the respective Board, and
- 2. have no conflict or apparent conflict of interest in the functions of the Board or the governance of the Village.
- It was, upon motion by Trustee Naughton, second by Trustee Folkerts, and unanimously adopted, to move to executive session to discuss personnel. No action taken. It was, upon motion by Trustee Swanson, second by Trustee Naughton, and unanimously adopted, to move back to public session.

There being no other matters to be brought before the Board; it was, upon motion by Trustee Folkerts, second by Trustee Naughton and unanimously adopted, to adjourn the meeting at 9:21 PM.
