Upon the receipt of the roll and warrant by you, and on or before the first day of May, you shall cause to be published in the official paper of the Village, once a week for two consecutive weeks, a notice that such tax roll and warrant have been left with you for the collection of taxes therein levied, and shall designate one or more convenient places in the Village where you will receive taxes from June 1st to and including July 1st from ten o'clock in the morning until 4 o'clock in the afternoon, Tuesday and Thursday; for said period of time you will receive all taxes paid to you without additional charge. 523 Long Beach Road

Upon an inspection performed on April 9, 2022, the dwelling located at 523 Long Beach Road, Village of Nissequogue, NY 11780, is considered to be unsafe as per Village Code 51-9-A. The dwelling is vacant and in a state of disrepair due to inadequate maintenance. The dwelling is not secure. There are multiple areas that are open, allowing access to the interior of the dwelling to both the public and wild animals. The interior of the building has been completely demolished. There is no access to the second floor. The records of the Building Department do reflect Permit #2516 issued for the interior demolition of the dwelling. This permit has since expired without having a Certificate of Compliance issued or the permit renewed.

There is also an inground swimming pool on site that is unsafe. The required safety fencing/barrier is not in place to protect the public from harm.

Photos have been taken to accurately show the existing condition of the property.
