SANTI & NANCY GRECO – 5 Pheasant Run, St. James, NY seeking Variances for the following Nissequoge Village Codes:

- 1. Village Code 128-24B (4) requires 100' front yard setback and applicant revised proposal 86' 4 3/8".
- 2. Village Code 128-24 B (5) & (6) requires side yard setback of 60' and 80' not to be less than 140' and applicant revised proposal 72' 2'' and  $60' 1 \frac{3}{4}''$  setback for a total of  $132' 3 \frac{3}{4}''$ .

Property is located on the north side of Pheasant Run and 1,071.87' west of Short Beach Road (Boney Lane) in the Village of Nissequogue, SCTM 802-1-2-5.8.

Michael Fazio the ZBA Chairman opened this public meeting stating the continuation of the prior hearings. The first hearing was held on Monday, November 22, 2021, and the second hearing was held on Monday, January 31, 2022. The applicants are seeking to renovate the structure, not to demolish the existing home.

Ron Zakary the architect for Mr. and Mrs. Greco presented to the ZBA board members his new revised site plan with front yard and side yard setbacks. The F.A.R. (Floor Area Ratio) is 950 sq ft below the F.A.R. The height has not changed and is at  $31' - 10 \frac{1}{2}$ ".

Desmond Murphy ZBA member said if the Variance is granted it be a required condition for the homeowner to submit a Foundation Location Survey, and Ridge Line Location Survey of the North side of the basement.

Michael Fazio closed the meeting stating that the ZBA board members will get together at a future date after the transcripts have been submitted from the court reporter regarding this hearing. The homeowners will be notified with the decision within sixty days of this hearing.
