RESOLUTION DECLARING THE HEAD OF THE HARBOR BOARD OF TRUSTEES AS THE LEAD AGENCY FOR PURPOSES OF A COORDINATED ENVIRONMENTAL REVIEW PURSUANT TO SEQRA FOR BIRDSFOOT FARM f/k/a PERRY FARM 17 & 21 SHEP JONES LANE, SAINT JAMES, NEW YORK 11780

WHEREAS, Avalon Nature Preserve, Inc. ("Avalon"), owner of the premises located at 17 & 21 Shep Jones Lane (SCTM: 0801-003.000-03.00-004.000, 005.001, 005.002 & 05.000-01.00-025.000), has applied to the Village of Head of the Harbor Board of Trustees ("Board of Trustees"), pursuant to Section 165-23(B)(3) of the Village Code, seeking a special permit to operate an agricultural use (farm) known as "Birdsfoot Farm" on the former Perry Farm property (the "Project"); and

WHEREAS, Avalon's Project also requires site plan approval from the Village of Head of the Harbor Planning Board ("Planning Board") and Zoning Board of Appeals ("Zoning Board"), which applications have been filed or will be filed in the near future; and

WHEREAS, the Board of Trustees is the sole approval authority with respect to the special permit for the Project; and

WHEREAS, the State Environmental Quality Review Act and its implementing regulations (SEQRA) requires that the significant adverse environmental impacts associated with the Project be identified, studied, and mitigated to the extent practicable before any final action on the special permit is taken; and

WHEREAS, the Project constitutes a Type I Action pursuant to Section 81-24(C), (D), and (F) of the Head of the Harbor Village Code; and

WHEREAS, the Board of Trustees circulate written notice of its intent to serve as Lead Agency for the Project on November 21, 2022, and more than thirty days have elapsed without objection from any Involved Agency;

 ${\bf NOW\ THEREFORE,\ BE\ IT\ RESOLVED},\ that\ the\ Board\ of\ Trustees\ of\ the\ Village\ of\ Head\ of\ the\ Harbor\ hereby:$

- Declares itself Lead Agency for purposes of a coordinated environmental review pursuant to SEQRA for the Project; and
- Directs the Village Clerk to send a copy of this resolution to the applicant, and to all Involved Agencies.
